

Conditions of Participation of the Care Concept "Welcome to Germany" Scholarship

Care Concept AG has decided to award a "Welcome to Germany" scholarship for the winter semester 2021/2022 (1 October to 31 March 2022). Care Concept AG intends to award the scholarship according to the following conditions. By participating, the participant declares his or her agreement with all the provisions of the following conditions of participation "Scholarship".

1. object of the scholarship

For the winter semester 2021/2022, Care Concept AG awards a partial scholarship for a stay of up to 6 months of a foreign student in Germany as part of their studies. The stay is supported with 300 EUR per month.

2. requirements for application

Students aged between 18 and 35 years can participate from the second semester onwards who have neither had a permanent residence in Germany for at least two years nor are German citizens. Furthermore, we expect the winner to be willing to provide a monthly personal report on his or her life and studies in Germany in German or English during the support period. Three of the reports must be written in text form (approx. 1 DIN A4 page, including three photos matching the report, on which the scholarship holder should be seen). The other three reports are to be produced as a short video of approx. 2 minutes in the appropriate format for Instagram Stories, on which the scholarship holder can be seen and heard for at least 30 seconds (including a photo with caption for the Instagram Feed, on which the scholarship holder should be seen). In addition, the scholar agrees to shoot a final video of the last 6 months at the end of the scholarship period (at least 2 minutes). Employees of Care Concept AG and their relatives cannot receive a scholarship.

3. application procedure

The participants should express why their study stay in Germany in particular should be supported by us. For this we need the complete documents by 01.08.2021. The complete documents include:

- a.) Fully completed application form
- b.) Creative letter of motivation with 3 photos (max. 1 page DIN A4)
- c.) Creative motivation video (max. 1 minute)
- d.) Specifying Facebook and Instagram Names
- e.) Current certificate of enrolment or letter of admission
- f.) Signed consent form

The documents must be submitted in German or English. The documents, letter of motivation and curriculum vitae must be submitted as PDF documents. The motivation video will only be accepted in the file formats .mp4, .mov, .avi, .wmv, mpg and up to a maximum file size of 1.5 GB. It is not possible to apply for several different Care Concept AG scholarships.

4. selection process

The selection of applicants for the final round is made on the basis of the submitted application documents by a selection committee made up of the Management Board and employees of Care Concept AG. Once the selection has been made, the motivation videos will be published online by Care Concept AG (Instagram and Facebook page, website, online portals). After publication, a public online vote on the winner takes place on the Care Concept AG student portal (www.care-student.de). The finalists can and should draw attention in social networks to their participation in the competition for a scholarship by, for example, sharing the video from the Instagram- or Facebook page of Care Concept AG. The scholarship holder is expected to be announced in September of the application year. The decision on the selection of the scholarship holder is final and no legal action will be taken.

5. exclusion from participation

Care Concept AG reserves the right not to admit applicants to the application process or to exclude applicants from the award of the scholarship in the event of incorrect information, intentional manipulation of the voting procedure or the selection process or for other important reasons (e.g. extremist, racist or pornographic content).

6. liability

Furthermore, Care Concept AG shall not be liable for damages which may arise as a result of errors, delays or interruptions in transmission, faults in the technical systems or the service, incorrect content, loss or deletion of data, viruses or in any other way during participation in the application process, unless such damages are caused by Care Concept AG (its organs, employees or vicarious agents) with intent or gross negligence or by breach of cardinal obligations. Liability for damage caused by injury to life, limb and health shall remain unaffected.

7. severability clause

Should any provision of this Agreement or any provision incorporated into this Agreement in the future be or become invalid or unenforceable, in whole or in part, or later lose its validity or enforceability, the validity of the remaining provisions shall not be affected thereby. The same shall apply if it turns out that the agreement contains a loophole. In the event of an invalid provision, the contracting parties shall be obliged to agree on a valid and reasonable replacement provision which comes closest to the economic purpose of the deleted provision in a permissible manner. The same shall apply in the event of the existence of a gap in the contract.

Declaration of consent

By signing this form, I expressly agree to the conditions of participation. Furthermore, I agree that the image/video recordings and texts created by me and/or relating to me may be used for the purposes of Care Concept AG's press and public relations work listed below.

I hereby declare my consent that the recordings and texts created may be used for the purposes of press and public relations of Care Concept AG.

I am aware that Care Concept AG cannot assume any liability for the illegal distribution of photo and video recordings and texts by third parties.

I guarantee that I can dispose of the rights granted and indemnify Care Concept AG against any claims by third parties asserted in connection with an alleged infringement.

Furthermore, I hereby declare my consent to the pictures/video recordings being shown together with general personal data. Furthermore, for this purpose I declare my consent to the collection, processing and use of my personal data insofar as they are related to my picture/video and my general personal data.

The consent is unlimited. The consent is also valid for the time after the end of the application procedure or the duration of the scholarship. It can only be revoked if there is an important reason for doing so.
