

Conditions of participation for Care Concept's Welcome to Austria scholarship

Care Concept AG has decided to award the "Welcome to Austria" scholarship for the 2023 winter semester (October 1, 2023 to March 31, 2024). Care Concept AG intends to award the scholarship according to the following conditions of participation. By taking part in the competition, the participant declares his/her/their agreement with all the provisions contained in the following "Scholarship" conditions of participation.

1. Subject matter of the scholarship

For the 2023 winter semester, Care Concept AG will award a partial scholarship for the stay of a foreign or German student in Austria for up to 6 months as part of their studies. The stay shall be financially supported with 300 EUR per month.

2. Requirements of participation

Participants are students between 18 and 35 years of age from the second semester onwards who have neither held permanent residency in Austria for at least two years nor are Austrian citizens. Furthermore, we expect the winner to be willing to provide a monthly personal report in German or English about his/her/their life and studies in Austria during the scholarship period. Six reports are to be produced as a short video of 1 minute in length in the appropriate format for Instagram reels and TikTok videos (1080px x 1920px), on which the scholarship holder can be seen or heard for at least 30 seconds. The reports should each include a photo that goes with the video for the Instagram feed as a cover picture, on which the scholarship holder should be seen. In addition, the scholarship holder agrees to shoot a final video of the last 6 months at the end of the scholarship period (1 minute long). Employees of Care Concept AG and their relatives are not eligible to receive a scholarship.

3. Application procedure

The participants should express to us why their stay in Austria for the purposes of studying should be financially supported by us. As part of this procedure we need the following documents by August 20, 2023:

- a.) completed application form
- b.) creative letter of motivation with 3 photos (max. 1 page DIN A4)
- c.) creative motivation video (max. 1 minute)
- d.) disclosure of Facebook, TikTok and Instagram names
- e.) current proof/certificate of enrollment or letter of admission
- f.) signed consent form

The documents must be submitted in German or English. The documents, letter of motivation and curriculum vitae must be submitted as PDF documents.

The motivation video will only be accepted in the following file formats: .mp4, .mov, .avi, .wmv, mpg and up to a maximum file size of 1.5 GB. It is not possible to apply for several different Care Concept AG scholarships.

4. Selection process

The selection of participants for the final round is made by a selection committee made up of Care Concept AG employees, based on the submitted application documents. Once the participants have been selected, the motivation videos are posted online by Care Concept AG (on Instagram, TikTok and Facebook pages, the website and online portals). After publication, a public online vote for the winner takes place on the Care Concept AG student portal (www.care-student.de). The finalists can and should draw attention to their participation in the scholarship competition on social networks by, for example, sharing the video from the Instagram, TikTok or Facebook page of Care Concept AG. The scholarship holder is expected to be announced in September of the competition year. The decision on the selection of the scholarship holder is final and is exempt from any legal procedures.

5. Exclusion from participation

If necessary, Care Concept AG reserves the right not to admit applicants to the application process or to exclude applicants from being awarded the scholarship in the event of incorrect information, deliberate manipulation of the voting procedure or due to other important reasons (e.g. extremist, racist or pornographic content).

6. Liability

Furthermore, Care Concept AG shall not be liable for damages which may arise as a result of errors, delays or interruptions in transmission, malfunctions in the technical equipment or services, incorrect content, loss or deletion of data, viruses or damages which may arise in any other way during participation in the application process, unless such damages are caused by Care Concept AG (its organs, employees or vicarious agents) with intent or gross negligence or as a result of a breach of cardinal obligations. Liability for damages resulting from loss of life, physical injury and harm to health shall remain unaffected.

7. Severability clause

Should any provision of this agreement or any provision incorporated into this agreement in the future be or become invalid or unenforceable, in whole or in part, or later lose its validity or enforceability, the validity of the remaining provisions shall not be affected thereby. The same shall apply if it turns out that the agreement contains a loophole. In the event of an invalid provision, the contracting parties shall be obliged to negotiate an effective and reasonable substitute provision that comes closest in a permissible manner to the commercial purpose of the invalid provision. The same shall apply in the event of the existence of a contractual gap.

Declaration of consent

By signing this form, I explicitly agree to the conditions of participation. Furthermore, I agree that the image/video recordings created by me and/or relating to me may be used for the purposes of Care Concept AG's media and public relations activities listed below.

I hereby declare my consent that the recordings created may be used by Care Concept AG for the following purposes:

- publication on the website as well as on various online portals of Care Concept AG so website visitors can be informed;
- publication of materials for advertising purposes by Care Concept AG (e.g. on flyers, posters and brochures);
- passing on to third parties, in particular print and online media (including the online and social media offers of the media); and
- publications on Instagram, Youtube, TikTok, LinkedIn and Facebook.

I hereby transfer to Care Concept AG the unlimited, irrevocable, royalty-free, worldwide, non-exclusive, sublicensable and transferable license to use the image/video material for this purpose. This license includes in particular the right to reproduce/copy, display, share, broadcast, make publicly available and otherwise display the images online and offline in the media specified.

I am aware that Care Concept AG cannot assume any liability for the unlawful distribution of photo and video recordings by third parties.

I guarantee that I can dispose of the rights granted and indemnify Care Concept AG against any claims by third parties asserted in connection with an alleged infringement.

Furthermore, I hereby declare my consent to the pictures/video recordings being shown along with general personal information. In addition, I declare my consent to the collection, processing and use of my personal data for this purpose insofar as it is related to my picture/video and my general personal information.

Consent is granted indefinitely and is also valid for the time after the end of the application procedure or the duration of the scholarship. It can only be revoked if there is an important reason for doing so.

I do not derive any rights (e.g. monetary compensation) from consenting to the publication of any materials.
